Payment Plan Policy

Esthetics Academy is committed to providing accessible education to aspiring professionals. We understand that students may require flexible payment options to enroll in our program. Therefore, in-house payment plans are available by request and are subject to review and approval by our Financial Department.

A minimum down payment of \$2,500 is required to begin any program under a payment plan. This down payment must be made in full by the first scheduled day of class. Approval of a payment plan is contingent upon submission of required documentation and a signed promissory note.

In cases of documented financial hardship, students may submit a written request for special consideration regarding the down payment or payment schedule. Each request will be reviewed on a case-by-case basis. Submission of a financial exception request does not guarantee approval, and all final decisions rest solely with the administration of **Esthetics Academy**.

While we maintain firm financial policies to ensure operational integrity, we strive not to turn away committed students based solely on financial constraints. We encourage prospective students to contact our Financial Department early in the enrollment process to explore available options.

Esthetics Academy-Enrollment Policies

Esthetics Academy welcomes dedicated individuals ready to pursue a professional esthetics education through our exclusive, one-on-one training model. Our boutique academy only accepts a limited number of students to ensure personalized instruction, hands-on support, and career preparation tailored to each individual.

To be eligible for enrollment, applicants must:

- Provide a valid government-issued photo ID (such as a driver's license, state ID, or passport).
- Submit a Social Security Number or Tax Identification Number (TIN).
- Provide proof of education through one of the following:

High school diploma or GED

High school transcript showing completion

Proof of homeschooling completion (as defined by Idaho state law)

College transcript showing an associate degree or higher

International applicants must submit validation from an approved agency confirming equivalency to a U.S. high school diploma.

To Complete Enrollment, Students Must:

- Schedule and complete an in-person tour and interview
- Non-Discrimination & Sexual Harassment Policy Acknowledgment
- Pay the \$200 non-refundable application fee

Upon review and acceptance, students will receive a formal enrollment agreement to finalize their registration and secure their training schedule.

Transfer Policy

Esthetics Academy may accept transfer hours from previously attended, licensed esthetics schools. To be considered:

- Submit a certified transcript from the previous institution
- Transfer hours must have been earned within the past 10 years
- The hours will be reviewed for approval by both Esthetics Academy and the Idaho Division of Occupational and Professional Licenses

Esthetics Academy-Student Policies

1. Introduction

Welcome to Esthetics Academy. This handbook outlines the school policies and procedures to ensure a professional, respectful, and safe learning environment. All enrolled students are expected to review and follow the guidelines stated herein.

2. Code of Conduct

Treat all staff, students, and clients with respect and professionalism.
No use of foul language, bullying, harassment, or discrimination of any kind.
Phones must be silent and put away during instruction and services.
Follow instructions from educators and administrative staff at all times.

3. Attendance Policy

Students must attend a minimum of 85% of the scheduled hours to graduate. Tardiness over 15 minutes may be counted as an absence. Repeated tardiness or absenteeism may result in probation or dismissal.

4. Dress Code

Students must wear professional black attire, including closed-toe shoes and an apron or smock. Hair must be neat, and hygiene maintained daily. No offensive or distracting clothing is permitted.

5. Sanitation and Safety

All students are responsible for maintaining a clean and safe workstation.
Sanitize tools and equipment after each use.
Follow bloodborne pathogen procedures as outlined in sanitation training.
Report all injuries or accidents immediately to an instructor.

6. Academic Progress

Students must maintain a minimum grade of 75% in both theoretical and practical evaluations. Failure to meet this standard may result in academic probation.

7. Disciplinary Action

Violations of school policy may result in a written warning, probation, suspension, or expulsion depending on the severity. All disciplinary actions will be documented in the student's file.

8. Grievance Procedure

Students may file complaints with the Academy Director in writing. All complaints will be reviewed within five business days and resolved through a formal meeting if needed. Unresolved issues may be escalated to the Idaho Division of Occupational and Professional Licenses.

9. Facility Use and Breaks

Students may use common areas during scheduled breaks only.

No eating in classrooms or service areas.

Keep noise levels respectful in all shared spaces.

10. Technology Policy

Use of cell phones, tablets, or other electronic devices during class or clinic is strictly prohibited unless approved by an instructor for educational purposes.

Program Description

The Esthetics Certificate Program is a 600-hour training course approved by the Idaho Division of Occupational and Professional Licenses. The program includes theoretical and practical instruction in facials, skin theory, hair removal, makeup, business, and Idaho state board preparation.

Payment Terms

Payment is due in full at the time of enrollment unless the student is approved for a payment plan or state funding. All payment plans must be agreed upon in writing before class begins. Payments must be made on time to avoid penalties or dismissal.

Refund Policy

Certification Training Academy LLC maintains a NO REFUND policy. Once enrolled, students acknowledge that tuition and fees are non-refundable regardless of withdrawal, dismissal, or program non-completion. Any exceptions will be at the sole discretion of the Academy Director in writing.

Attendance and Conduct

Students are expected to attend a minimum of 85% of scheduled hours and maintain satisfactory academic and professional conduct. Violations may result in probation or dismissal.

Student Indemnity, Waiver & Liability Agreement

By enrolling in any program at **Esthetics Academy**, the undersigned student hereby agrees to the following terms, which are binding upon enrollment and throughout the duration of their program:

Waiver of Liability

The student voluntarily assumes all risks associated with participation in esthetics training and related activities conducted on or off-campus. This includes, but is not limited to, the use of tools, machines, products, chemicals, and participation in practical clinic services.

The student hereby releases and holds harmless **Esthetics Academy**, its owners, employees, instructors, agents, and affiliates from any and all claims, demands, damages, costs, or liabilities arising from injuries, accidents, illnesses, or losses, whether physical, financial, or emotional, incurred during training. Indemnification.

The student agrees to indemnify and defend **Esthetics Academy** and its representatives against any claims, liabilities, or legal actions resulting from the student's actions, negligence, or violation of school policy during the course of enrollment. This includes any third-party claims resulting from student-performed services on or off-site.

Tuition Obligation & Bankruptcy Disclaimer

Enrollment in **Esthetics Academy** constitutes a binding financial agreement. The student acknowledges that tuition and fee obligations are not dischargeable through bankruptcy and remain the responsibility of the student until paid in full, regardless of personal financial circumstances or legal filings. Failure to pay in accordance with the agreed payment schedule may result in late fees, collection actions, and legal recourse.

Documentation must be submitted before enrollment begins. Hours not approved or submitted late will not be applied to the current program.

Re-Entry Policy

Students who previously withdrew or were dismissed and wish to re-enroll must:

- Wait a minimum of six (6) months from the last date of attendance
- Submit a new Application for Admission
- Provide a formal letter explaining the reason for their prior withdrawal and outlining why they're prepared to succeed now

The re-entry request will be reviewed by **Esthetics Academy's** administrative team. Students accepted for re-entry will resume their academic progress from the point of withdrawal, unless otherwise determined due to poor performance or attendance.

In cases where a full restart is required, prior hours, grades, and tuition payments will not carry over to the new enrollment period.

To successfully graduate from **Esthetics Academy** 600-hour the following requirements must be met:

- Student has clocked a minimum of 600 program hours.
- Student has passed both the Idaho Laws & Rules and Program Final exams with a passing grade of 75% or higher.
- Tuition and any overage charges are paid-in-full OR the student has a fully executed payment agreement with the school.
- Student has completed the requisite 600 hour program.

Termination Policy

Esthetics Academy reserves the right to terminate a student's enrollment at any time for conduct or behavior that compromises the safety, integrity, or educational mission of the school. Termination may be immediate and without refund under the following circumstances, including but not limited to:

- Failure to pay for personal services received from the student clinic
- Theft or unauthorized removal of school products, tools, or property
- Refusal to follow instructor directives or consistent disruption of the learning environment
- Academic dishonesty, including cheating or falsifying documentation
- Attending school under the influence of alcohol, illegal substances, or the misuse of legal drugs
- Possession, use, or distribution of alcohol or drugs on school premises
- Engaging in sexual harassment, hate speech, or discriminatory behavior toward students, staff, or clients
- Acts or threats of physical violence directed at any member of the school community
- Possession or display of a weapon on school premises
- Accumulation of 14 consecutive calendar days of unexcused absence
- Failure to meet financial obligations, including nonpayment of tuition or outstanding balances

Termination decisions are made at the sole discretion of school administration and are final. All terminations are documented and may impact future eligibility to re-enroll or transfer to other institutions.
